The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Global Services Promotion Programme. The Ministry of Planning and Sustainable Development, intends to apply part of the funds to the Interior Design and Supervision of the Outfitting of the Global Services Internationalization (GSI) Hub. The GSI Hub will offer the following services:

- **Training and support services:** These services will target companies and entrepreneurs in the ITeS industry who are currently exporting and wish to expand or local companies who wish to compete internationally.
- **Finishing Schools:** This aspect of the programme will involve the execution of a gap analysis and the implementation of short-term technical training based on the identified needs.
- Collaborative Physical and Technological Infrastructure: The GSI Hub will offer technological infrastructure enabling plug and play operations for investors and workspaces for students and local service providers designed to foster networking, collaboration and research and development. In order to facilitate the participation of women in the services offered by the GSI Hub, a childcare facility and a lactating room for nursing women will be offered.

The services for the interior design and supervision of the outfitting of the GSI Hub include but are not limited to the:

- Proposal of conceptual designs;
- Preparation of detailed interior architectural drawings and design specifications;
- Provision of a Bill of Quantities for building out the selected design; and
- Supervision of the outfitting of the building located at No. 25 Ramsaran Street, Chaguanas, Trinidad and Tobago, to accommodate the GSI Hub.

The Ministry of Planning and Sustainable Development now invites eligible firms to indicate their interest by providing information establishing that they are qualified to provide the required services including a background of the firm, a description of similar assignments undertaken, experience in similar conditions, availability of appropriate skills among staff, financial capacity etc.). Interested firms should have experience in the interior design and supervision and possess a track record of successfully carrying out similar projects.

Firms will be selected in accordance with the procedures as specified in the Inter-American Development Bank's Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank (current edition) and is open to all eligible bidders as defined in the policies which can be found at website: http://www.iadb.org/procurement.
