TTCSI Cultural & Creative Workshop













TTCSI in collaboration with the Caribbean Export Development Agency (Caribbean Export) and Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH conducted a Cultural and Creative Industries Workshop in Trinidad and Tobago on the 27-28 March, 2019 at the Hilton Trinidad.

The workshop was attended by 19 participants from Barbados, Belize, Dominica, Grenada, Jamaica, St. Lucia, St. Kitts & Nevis, St. Vincent & The Grenadines and Suriname. There were also 50 delegates from T&T. The participants represented the Fashion, Music and Animation sectors and during the two-day workshop focused on issues related to creating a unique value proposition, branding and marketing, pricing, quality and standards, product development, intellectual property, opportunities under the CARIFORUM-EU EPA and an introduction to export planning.

This workshop represented one of several initiatives being undertaken by the TTCSI to stimulate growth of the services sector, as the TTCSI views this sector as a key catalyst towards the transformation of the national economy.

The Internet of Things (IoT) - physical objects embedded with software, sensors, and network connectivity - are poised to play a key role in enabling resilient and equitable management of urban environments. IoT can provide real-time data collection on the availability and use of resources, facilitating more informed resource conservation, and can streamline data collection on traffic patterns and parking availability, decreasing gas consumption and CO2 emissions. The presentation also provided examples of the application of IoT for sustainability in all sectors and offers recommendations to organisations seeking to implement IoT technologies.

The Les Roches Global Hospitality Education partners with the Caribbean Hotel and Tourism Association Education Foundation to provide scholarships. This prestigious Swiss hospitality school will provide partial scholarships for Caribbean nationals seeking undergraduate degrees at the elite tertiary institution.

Les Roches will supplement CHTAEF's annual US\$5,000 bursary each year with a 20 to 25 percent scholarship for each recipient over three-and-a-half years.
